Annual Meeting Minutes February 28, 2022

A Meeting of the Board of Directors of The Barracks at Rock Prairie Owners Association, Inc. (the "Association") was held at the Best Western Premiere Hotel located 1920 Austin's Colony Pkwy, Bryan, TX at 11:00 a.m.

I. Call to Order

The Meeting of the Board of Directors of the Association was called to order by Luke Marvel, Board President of the HOA at approximately 11:05 a.m. CST.

II. <u>Determination of Quorum</u>

A quorum existed due to at least twenty percent (20%) of all votes entitled to be cast being present at the meeting. Ross Newcomb, Board Director served as the Secretary of the meeting.

III. Proof of Notice of Meeting

Hollie Walston, HOA Manager presented an affidavit of notice of mailing to all members of the Barracks at Rock Prairie HOA to their last registered address with the HOA. The affidavit is attached hereto as **Exhibit 'A'**.

IV. Reports of Officers

Luke Marvel called the members names that were listed on the sign-in sheet. Mr. Marvel also gave an update on the approved 2022 budget. He reported that a dues increase was enacted this year as of January 1, 2022. The monthly amount was increased \$14.00 per lot as decided at the Open Board Meeting on November 17, 2021. Mr. Marvel explained that a future raise is not anticipated in 2023. Mr. Marvel then introduced Board Vice President, Andrew Jeffress, who reported on several updates related to the community in 2021 including:

- Repairs to sun-bathing pool; replaced 10 lounge chairs and the sand filter. Also repaired all pipes due to the winter storm.
- Improvements to city parks regraded sand volleyball courts on Cullen Trail.
- Major community improvements/remediation \$30,000 spent on community mulching, and \$45,000 repainting doors, staining fences, and re-striping driveways for 20% of community.
- Nine new dumpster pads were constructed in the community.
- First Special Assessment: All fences on lots 3300-3353 General Pkwy, Corporal Ave, Sergeant Dr and Lieutenant Ave were replaced in January.

- Community events Sunset Cinema, Trivia Nights, Rock Paper Scissors Tournament, Barracks Olympics, and Dog Park activities.
- Cove & Longshot Cove hours were extended to be open six days a week, Longshot Hash House open 7 days a week.
- Construction update widening of Rock Prairie anticipated to be under construction until the end of this year.
- Awards The Barracks Townhomes wins *Best of The Brazos* in student housing category for the seventh year in a row.

The Board also yielded the floor to the members for questions, which included:

Updates or concerns of trash issues – Angie Hoermann, Ward Scott

Construction of The Harbor - Cissy Johnson

V. Adjournment

There being no further business to come before the meeting, it was adjourned by unanimous agreement at 11:36 a.m.


